Space for the Holiday Market is limited and is assigned on a first-come, first-served basis. Current VFM Vendors will receive priority until September 30th, 2017. **All fees are required with your application, or it will not be considered.** If you are a new vendor, your check will be held until you have passed jury and are approved to sell. Your payment secures your space and is **non-refundable after November 5th, 2017**, or your jury date, whichever comes last.

Vendors will be provided an 8' x 3' table, tablecloth, skirting and chair(s) free of charge by request. Tent canopies are not allowed but, tent skeletons or free standing side walls may be used in your booth. The VFM will provide advertising, as well as materials for you to do your own advertising. WiFi will be provided free of charge for all vendors.

Non-VFM Members:

1. New vendors must attend and pass a jury (free of charge) to participate in the market. Vendors may only sell products that they have juried, all other items will be ineligible for sale. The Vancouver Farmers Market will contact you via email to inform you of the time & place of the jury. If you are a returning Holiday Market vendor selling the same products, you are not required to re-jury.
2. Passing the Holiday Market jury/approval process does not carry over to the 2018 outdoor market season. If you wish to sell at the VFM in 2018, please apply online when the application process opens. Our website will be updated with application details in December.
3. New vendors will be required to provide proof of appropriate licensing (i.e. business license, health department permits etc.). WA State Business Licenses are required for all participants.

Current VFM Members:

1. Current VFM Vendors may only sell what they are approved to sell during the regular market season. If you plan to sell new items, you must jury them in for the Holiday Market.
